To use the **Schedule Matrix**: Your **Team Number** is the number to the left of your team name in the list of teams. Find this number on the left edge of the schedule matrix. Each box to the right represents one game day for your team. If the box is shaded you do not have a game this day. Numbers in the boxes are the Team Numbers of your opponents. If the word "at" is in front of that number then you are the away team. If nothing appears in front of that number then you are the home team.

Games may be rescheduled with the agreement of both teams and the League Administrator using the online **District 1 Game Schedule Form**, available from the District 1 web site, www.wsysad1.com. Use the Game Number above the Schedule Matrix to specify which game you are rescheduling. If a game is rescheduled, remember it is your responsibility to inform your field scheduler and referee assignor.

The assigned home team is responsible for providing adequate information to the opposing team regarding game time, field, and directions **at least 72 hours prior to the game**.

The coach or manager of both teams, winning or losing, must report the final score within 72 hours after completion of the game to support timely standings update.

Electronic score reporting has been implemented through the District 1 website. Each team should designate an individual with internet access to fulfill the score reporting responsibility.

League standings will be published via the District 1 website. The internet may generally be accessed through local library system.
